

## TERMS AND CONDITIONS

### **Payment:**

A deposit of \$500 per person must accompany your reservation to hold your position on the tour. The unpaid balance must be paid no later than 60 days before the tour date listed in your adventure packet. Open Road Motorcycle Adventures LLC may cancel your reservation if payment is not received by the closing date. All prices are in US dollars. We accept Visa, American Express and MasterCard for reservation deposits and final payment. Checks and Money Orders will also be accepted. Final reservations are guaranteed once personal checks have cleared and all funds are received by Open Road Motorcycle Adventures, LLC.

### **Refunds and Cancellations:**

Participants who cancel their reservations will receive refunds as follows:

1. More than 60 days before the tour – Refund of deposit, less \$150 fee per person.
2. Less than 60 days but more than 30 days before the tour – Refund of 50% of the tour price.
3. No refunds can be made later than 30 days prior to the tour date.

If Open Road Motorcycle Adventures LLC cancels a tour for any reason, all money paid to us will be refunded, or you may elect to join another tour. We cannot refund the cost of “non-refundable” airline tickets and while our tours are not normally cancelled, we recommend purchase of travel insurance for protection from such expenses. If an alternate tour is selected, any difference in cost must be paid or will be refunded.

### **Open Road Motorcycles Adventures LLC Responsibilities**

All tours are continually refined and updated to maximize the personalized treatment and enjoyment of our participants. We reserve the right to modify, without notice to our participants, any tour as needed to accommodate operating needs or circumstances beyond our control. This includes but is not limited to, hotel and dining arrangements, routes and itinerary. In the event substitutions are made, we still strive as far as practical and possible to insure that all features of the tour are of similar or better quality than those originally planned. We will transport your luggage in our support vehicle and/or trailer,, but assume no responsibility or liability for costs or damage related to lost or damaged baggage other than to provide reasonable care and security for your property.

While Open Road Motorcycle Adventures LLC is acting as my agent to obtain accommodations and meals, provide guide services and may assist me in obtaining a rental motorcycle for this tour, I understand that Open Road Motorcycle Adventures LLC has no affiliation with any motorcycle rental, transport or storage company and it assumes no responsibility for services, or lack thereof, provided for motorcycle rental, shipment or storage. I agree to indemnify and hold Open Road Motorcycle Adventures LLC harmless against any and all claims, causes of action or liability of any kind arising from the rental, transport or operation of a motorcycle.
